## The role

We are looking for a **Clinician** to bring their experience to our team. The purpose of the role will be to assess the treatment and support needs of child, youth and adult clients who have engaged in harmful sexual behaviour, and work alongside whānau, and other supports who have been impacted by this behaviour.

## The ideal candidate will have:

- A recognised qualification in psychology, social work, counselling, or similar.
- Be registered with a professional body and have a current Practising Certificate (or be in the process of obtaining).
- Training and experience in delivering clinical and evidence-based treatment.
- Experience in the use of psychometrics, assessment, and formulation of client issues.
- Experience creating safety plans.
- Report writing experience.
- Experience in working with issues of sexual abuse, trauma, mental health and/or intellectual disability would be advantageous.
- The ability to work in a culturally responsive manner that demonstrates a commitment to Te Tiriti o Waitangi including experience with Kaupapa Māori models of practice.
- Connections with the local community and an ability to work effectively and collaboratively with whānau, hapu and Iwi.
- You will be required to drive so a FULL NZ driver's licence is required.
- To be considered for this position you must already be located and resident in NZ have either NZ citizenship/residency or a valid NZ work visa.
