## The ideal candidate will have:

- A recognised qualification and registration in Social Work, Counselling or similar, although unregistered practitioners will be considered for a Support Worker role.
- Be registered with a professional body and have a current Practising Certificate (or be in the process of obtaining).
- Experience in the delivery of psychosocial crisis support services that take a trauma informed approach.
- Training and experience in delivering clinical and evidence based interventions.
- Risk assessment and Safety Planning formulation.
- The ability to work in a culturally responsive manner that demonstrates a commitment to Te Tiriti o Waitangi including experience with Kaupapa Māori models of practice.
- Experience of working collaboratively and effectively in a multidisciplinary team.
- You may be required to drive so a FULL NZ driver's licence is required.
- To be considered for this position you must already be located and resident in NZ have either NZ citizenship/residency or a valid NZ work visa.
